### **City of Oakland Construction & Demolition Hauling Requirements**

Building owners, business owners, and general contractors, may self-haul construction & demolition debris **ONLY** by using their own fixed body trucks and employees (no trailers or debris boxes).

Unless self-hauling as described above, owners and contractors must hire **ONLY** haulers with <u>Non-Exclusive Franchise</u> (NEF) issued by the City of Oakland to transport construction & demolition debris (https://www.oaklandca.gov/resources/rules-for-transporting-construction-and-demolition-debris). This also applies to Tenant Improvements (TI) when the tenant is responsible for the construction project.

Hiring unauthorized haulers (or demolition companies that do not have NEF) may result in fines, penalties or prosecution.

Hire **ONLY** authorized NEF haulers from the City's list of authorized NEF haulers to transport construction & demolition debris.

#### Compost & Recycle Service is Mandatory for ALL Business, No Matter the Size

Even if your business doesn't sell or manufacture food, your business still needs to dispose of compostable materials such as food eaten in break rooms (coffee grounds and filters, food scraps, food-soiled paper) into a compost container. You are also required to sort empty, clean and dry paper, cardboard, glass bottles and jars, plastic bottles, tubs and jugs, and metal cans into the recycle container.







#### SB 1383 State Law Mandates:

- All sites must have compost and recycle collection service and properly sort waste into compost, recycle, and trash.
- Place color-coded and labeled compost and recycle containers next to all indoor trash containers (excluding restrooms). Free help and indoor green bins are available.
- Large businesses that generate surplus edible food—such as grocery stores, food distributors, and large restaurants—must donate food to food recovery organizations.
